EXPLANATORY STATEMENT PURSUANT TO THE PROVISIONS OF SECTION 102 OF THE **COMPANIES ACT. 2013**

Mr. Deepak Kumar Singal was appointed as Managing Director of the Company for a period of five years with effect from 30th September, 2019, after obtaining due approval of the members of the company in their Annual General meeting held on 30th September, 2019. Further he was re-designated as the Chairman cum Managing Director of the Company vide Board Resolution dated April 30, 2022 and special resolution dated May 22, 2022. Accordingly, the present term of Mr. Deepak Kumar Singal come to an end on 29th September, 2024. However, the Board of Directors has approved the re-appointment of Mr. Deepak Kumar Singal as Managing Director of the Company for a further period of five years with effect from 19th January, 2024 to 18th January, 2029, subject to the approval of the members of the company. The Board has taken the decision of the said re-appointment based on the recommendation of Nomination and Remuneration Committee and subject to the approval of the members of the company.

Further, Mr. Deepak Kumar Singal, is not disqualified from being appointed as Chairman cum Managing Director in terms of Section 164 of the Companies Act, 2013 and has given his intimation in Form DIR-8 in terms of Companies (Appointment & Qualification of Directors) Rules, 2014 to the effect that he is not disqualified under sub section (2) of section 164 of the Companies Act, 2013.

Furthermore, Mr. Deepak Kumar Singal, is eligible to re-appointed as Chairman cum Managing Director in terms of Section 1 of Schedule V of the Companies Act 2013.
